Enclosed, please find our completed application for your review.

This application is submitted as a companion application to the project approved by this IDA on behalf of KADGE, LLC on November 13, 2018. This applicant (Orange County Ironworks, LLC) ("Orange") has common ownership with KADGE, LLC and will occupy one of the new buildings to be constructed under the KADGE, LLC project. In conjunction with the KADGE project, Orange will acquire a substantial amount of equipment for use in the steel fabrication business. This equipment has an estimated value of \$3 million and will be acquired by Orange and will be located in the building to be constructed by KADGE. The purpose of this application is to facilitate the project by enabling Orange to have the benefit the sales tax exemption for its purchase of equipment for the project. Therefore, to the extent that equipment is purchased by Orange, rather than KADGE, the tax benefit would flow to Orange and not KADGE.

Because the KADGE and Orange projects are truly a single project, the public benefits disclosed in this application are the same as those disclosed in the KADGE application.
